Narrabri Main Street Upgrade Community Update

There are exciting times ahead for Narrabri's CBD as we commence work on Stage One of the CBD Masterplan!

The Narrabri CBD Masterplan is the key document guiding the future of CBD upgrade work and strategic planning initiatives. Positive economic and social outcomes have been provided for together with significant streetscape and amenity improvements.

Stage One will address:

New CBD Lighting in the core CBD Blocks

Increased shade with centre median tree plantings

No loss of CBD Car Parking

Information about the project including a Fact Sheet is now available online on Council's website and Facebook page.

Council staff have been visiting all businesses in the three affected blocks to speak to them about the project, outline the timeframe for the works and explain how works will be undertaken and the main street will be affected. Fact Sheets have been delivered to these businesses and email addresses collected to keep businesses up-to-date with the project.

Works are expected to commence in the first week of July 2017. Council has been working closely with the contractors Curry Power to develop Traffic Management Plans to create minimal disruption to main street traffic. Blocks will be worked on separately with works within one block completed before the next one commences.

Major works are scheduled to be completed by October 2017 prior to the peak Christmas shopping period.
